# **About the Program**

The ECYA program is an accelerated program specially designed for those who have completed an undergraduate degree. In the accelerated program, you are eligible to earn your Early Childhood Education diploma in 12 months.

In this three-semester diploma program, you will learn about the physical, cognitive, social and emotional needs of children. You will understand how to develop and implement inclusive programming in order to support the healthy development of children ranging in age from infancy to school-age.

Your studies will include courses in child development, curriculum, philosophy of education, communication, working with families and administration.

To practice in Ontario as a Registered Early Childhood Educator (RECE) graduates must apply for registration with the College of Early Childhood Educators (CECE) (http://www.college-ece.ca/). Graduates of this program will meet the educational requirement for membership.

- Assess, develop and maintain safe, healthy and quality early learning environments which meet the requirements of current legislation, agency policies and evidence-based practices in early learning.
- Prepare and use professional written, verbal, nonverbal and electronic communications when working with children, families, colleagues, employers, and community partners.
- Identify, select and apply relevant legislation, regulations, College of Early Childhood Educators Standards of Practice and Code of Ethics, policies and evidence-based practice guidelines, and interpret their impact on a variety of early learning environments.
- Apply a developing personal philosophy of early learning in accordance with ethical and professional standards of early childhood education practice.
- Advocate for quality early learning environments and collaborate with members of the early learning team, families and community partners to establish and promote such settings.
- Engage in reflective practice, develop learning goals and maintain an ongoing professional development plan in accordance with evidencebased practices in early learning and related fields.

# Admission Requirements

· Ontario university or college degree, or equivalent

Canadian citizens or permanent residents educated outside of Canada must provide a World Education Services (WES) or ICAS Canada credential evaluation.

## **Additional Information**

Postsecondary English course equivalency can be demonstrated through the following:

 Completed postsecondary credential from an institution and country where English is the primary language spoken (Canada or one of the countries listed here (https://www.senecapolytechnic.ca/ registrar/canadian-applicants/admission-requirements/englishproficiency.html#exempt-list))

To comply with the requirements of field placement organizations, you must have these documents prior to the start of the term. Documents must be valid for the duration of the placement semester:

- · Vulnerable Sector Police Record Check
- Medical form: which includes current immunization and chest x-ray or tuberculin skin test reports
- · Standard First Aid and CPR-C
- · International students will need a valid Co-op Work permit.

To prepare for field placement students will receive an email invitation to attend an online Field Placement Orientation session. This session will provide you with helpful tips on how to complete these important documents.
